### SECTION 2: HAZARD IDENTIFICATION

#### **Biological Hazards**

Components used in glove manufacturing may cause allergic reaction in some user.

#### **Hazards related to the re-use of the medical device**

Re-use of the non-sterile single use medical glove may lead to:

- Loss of product lot traceability
- Risk of contamination and infection increases due to improper cleaning process

Damages / weakening by the cleaning processes leading to increased risk of holes and tear during re-use

Acrylonitrile Butadiene Rubber, Zinc Oxide, Potassium Hydroxide, Titanium Dioxide, Blue Pigment
