SECTION 2: HAZARD IDENTIFICATION

Biocompatibility:

- The chemical composition of the gloves and the surface lubricating materials do not contain any substances or heavy metal normally known to be harmful to the user or to any person with whom the gloves get contact
- The glove is tested for primary skin irritation on rabbit. There was no irritation observed on the skin of the rabbits

The glove is tested for dermal sensitization assay on guinea pigs. There was no sensitization induced in the albino guinea pigs
